- 1. Small Business Trends Online article (3/10/25): The Small Business Administration (SBA) announced the launch of the Made in America Manufacturing Initiative, an effort aimed at revitalizing American manufacturing by cutting regulations, expanding access to capital, and strengthening supply chains. - 2. CT News Junkie article (3/7/25): Advocates, including EWIB President Michael Nogelo, stress the importance of funding for the Connecticut Youth Employment Program (CYEP). Jenna Grasso from CBIA commented that "Connecticut employers, who are already struggling with a workforce shortage, want to connect with young workers and bring them into their businesses. Connecticut's youth deserve access to programs that strengthen workforce pipelines and enable career opportunities." Read more here.

CBIA article (3/4/25): With recent changes in federal immigration policy, many manufacturers are feeling anxious about visits from U.S. Immigration and Customs Enforcement (ICE) and uncertain about what to do should such a visit occur. While ICE enforcement activity at ordinary places of business may be unlikely, it is best that manufacturers be prepared. Read their suggestions here.

Norwich Bulletin article (2/26/25) (Paywall): This article explores Electric Boat's hiring plans for 2025, which include at least 10% of the 3,000 anticipated hires this year to be recent high school graduates. EAMA RSP Chair Chris Jewell, of Collins & Jewell noted that while EB's hiring has slowed, this provides an opportunity for the members of EAMA RSP to hire graduates of the Manufacturing Pipeline Initiative (MPI). Federal Reserve Bank of Boston article (2/21/25): Federal Reserve Bank of Boston president Susan Collins visited Connecticut to tour and learn more about Eastern CT's Manufacturing Pipeline Initiative (MPI). Grasso Technical High School in Groton, where she heard from EAMA RSP companies and support partners about the MPI's demand-driven approach and employer-led partnership. - 6. *CBIA* article (1/21/25): Connecticut's Manufacturing Innovation Fund (MIF) was created in 2015 to support the growth, innovation, and progress of the state's advanced manufacturing sector. The fund's fiscal year 2024 report details its support of Connecticut's critical manufacturing sector, including facilitating access to financial resources, technical expertise, and skilled workers. Administered by the Dept. of Economic and Community Development's Office of Manufacturing and overseen by an advisory board, the fund provides direct loans and/or grants to support an array of initiatives for manufacturers.
